

## “NO CONTRACT / NO VOTE”

WE the VOTING POPULATION of The United States of America, in order to form a more ACCOUNTABLE GOVERNMENT, hereby require that all ELECTED REPRESENTATIVES prior to any election for public office sign an EMPLOYEE CONTRACT AGREEMENT. *We the People*, using the *Constitution*, the *Contract Law*, the *Internet*, and *Paypal*, hereby place total democratic control over all of our elected officials by utilizing the CONTRACT CONTROL POLITICAL OPERATING SYSTEM.

The CONTRACT CONTROL POLITICAL OPERATING SYSTEM is not part of the GOVERNMENT, nor is it a Political Party, but is formed by the citizens outside of government, for government will never place controls on itself. The SYSTEM provides the means for the CITIZENS OF THE UNITED STATES OF AMERICA to have democratic voting control over their *local*, *state*, and *federal representative* for the expressed purpose of having their decisions honored in all matters concerning government business; Thereby, effectively isolating the DULY ELECTED REPRESENTATIVE FROM OUTSIDE INFLUENCE AND UNAUTHORIZED DECISIONS.

The SYSTEM uses property designations such as a “Street within a Subdivision”, “County”, and “State” to formulate the basis by which a group of citizens can create a legal entity as a CONTRACT CONSORTIUM VOTING ORGANIZATION. Each individual Consortium Organization prior to a formal election, signs a contract with the potential candidate, or candidates, that want their support and votes. Once in office, the *duly elected official*, as an EMPLOYEE OF THE PEOPLE, will without fault, cast his or her official vote on any and all matters pertaining to the legal body in question by the outcome of a *Vote of the People*, by way of the CONTRACT CONSORTIUM ELECTRONIC VOTING SYSTEM; per the terms of the *Contract Agreement*.

The *Contract Consortium Electronic Voting System* accepts all registered voters and non-registered adult citizens without reference to *age*, *race*, *religion*, *economic* and/or *physical status*. The systems function is to provide a secure timely voting mechanism for any and all issues that each Sector of a *Consortium District* deems relevant to its member’s *physical*, *economic*, and *security interests*. The System will allow each member the right to cast one(1) electronic, FOR or AGAINST vote, *per issue*, by way of a Paypal account,

provided his or her citizenship and adult status has been physically verified and that he or she has been properly examined for deception and or fraud by *Computer Voice Stress Analysis* (CVSA) to ward against outside monetary control and/or coercion.

The objective of this new political operating system is to provide true democratic control over the governing of THIS GREAT NATION, while providing *detection of, and protection from, all forms of domestic enemies.*

## **SECURING OUR CONSTITUTION AND OUR SOVEREIGNTY**

Note: A domestic enemy is any person and or organization THAT:

1. Conspires to economically alter the U.S. Economy by using government power and/or profits from the operation of/or the manipulation of any level of a *United States Governing Body.*
2. Attempts to adjust, change, or remove a CONSTITUTIONAL RIGHT as stated in the ORIGINAL DOCUMENT.
3. Conspires to use government power to maintain a financial position of advantage that escalates the cost of goods or services that an American citizen would have to burden the additional cost of said manipulation.

### **Community Organizing for Truth, Justice, and the American Way**

*Your mission, should you choose to accept it:*

1. To ensure that America has a completely truthful, 100% uncontrolled, hand-delivered, door-to-door, *Citizens Media Network.* Yes this is the information age, but the same has fractionalized the delivery system to the point that information about our government cannot be verified and timely assimilated. The process must return to the paper era, to insure that all BLOCK

PARTICIPANTS and NON-PARTICIPANTS have the information necessary to make an intelligent decision based on the truth of any issue that is brought up for any vote. The *Citizen-to-Citizen System* is designed to expeditiously deliver CVSA Certified news, notices, and economic warnings to every household and business along with internal government corruption information. Notices will be hand-delivered to each household then the body of information will be placed on the CVSA Media Network website or sent via PDF file to all registered participants.

2. To personally contact all United States citizens on your street block, no matter how offensive, eccentric, or obnoxious the individual. The process must be all inclusive and completely open.
3. To ask your neighbors to help contact other neighbors to facilitate total participation
4. To convince those who have never voted, never cared, never participated in the political process to help us and you, secure America from all domestic and economic enemies. Ask them to immediately register to vote. Help them to realize that their registration will send a clear message to the political world that all of the people are awake and that *democracy, and not special interests*, will rule this Great Nation!
5. To relay the fact that these Citizens, the frustrated, the hopeless, the cynical and the disenfranchised are now the most powerful citizens in our country. Let them know that with our help they can SCREW THE SYSTEM down tight! Their participation can put an end to special interests controlling our government. WE THE PEOPLE will have power to initiate real change and usher in a new era, when the individual is no longer left powerless in his or her own government.
6. To reinforce the fact that this is the beginning of the end of corruption, theft, and the manipulation of our government and our way of life in America.
7. To print and hand deliver the info sheet for your blocks first CONSTITUTIONAL CONTRACT CONSORTIUM MEETING. (Note your block meeting should be scheduled no later than three weeks from the first contact.)
8. To inquire as to who would be available to help plan the meeting. An outdoor block party in the street would be the most visible, inviting, and open, or an

event such as a barbeque, a fish fry, or a potluck event. A block meeting prep sheet will be passed out so that your block can more effectively plan logistics.

Note; You should not file for a BLOCK PARTY PERMIT from your local government. Try setting up your pop up tents and equipment on the area between the sidewalk and the street. Select two, four, or six opposing homes so that the party will be concentrated between the two sides of the street and spill into the street to create the same effect. A Sunday evening, 4pm-7pm time frame may attain the most attendance.

9. To develop a database of individuals that understand that democratic control over our elected *employees* is paramount to our *National Economic Security*.
10. To give each household three CGP Sheets, (Concerns, Grievances, Problems) —one each for *local, state, or federal issues* that anyone feels a need for any of them to be discussed. The purpose is to identify genuine topics that you and your neighbors believe could or should be changed and/or addressed in or by government when your contract employee is elected. The lists are how WE THE PEOPLE will decide which ones are important to our welfare and security. They will also help us formulate and bring forward rational solutions for these issues.
11. To prioritize, categorize, and pass these lists forward to other blocks on your street so they can do the same. Then pass them on to your neighboring street, and finally to your subdivision office. These will be the first CGP's to be brought forth for and OFFICIAL VOTE on the CONTRACT CONSORTIUM ELECTRONIC VOTING SYSTEM.

Note; Each Subdivision office will be formed once all the individual streets are organized, and a representative from each street is selected by its members—to be followed by the County and then the State office.

12. To move decisively to re-deliver completed info sheets. Your CGP sheets will help others realize that no one citizen, no one street, no one community is alone when STANDING UP for *Truth, Justice, and the American Way*.
13. To remember that there is serious strength in an American Citizen that is involved in preserving his or her own personal and economic freedom.

Note; overlapping CGP sheets from other streets will only reinforce the strength of democracy.

14. To formulate a plan to organize a PRIVATE STREET CLUB of participants on your street that will become a part of your subdivision's FORMAL LEGAL ENTITY used to sign contracts with potential candidates. After all street clubs in your subdivision have been organized, a separate legal entity can be formed in which all individual clubs will be represented equally under your Subdivision Contract Consortium Organization, LLC.

*Note-1;* All individual club membership roles should remain confidential so that no third party or government entity can access the list for subversive purposes and/or allowed anyone to know the true number of members. Only one member per club will cast your sheets official tallied vote on any issue. The previous will allow the CVSA system to work without interference from domestic enemy forces.

*Note-2;* Do not be offended by those who are reluctant to participate as initial members for the LLC operating agreement; All adult, non-criminal U.S. Citizens may join after the Contract Employee is elected—they will be more informed after witness of effects of the CVSA Media Network in each door-to-door delivery system.

15. To email, snail mail, and/or hand deliver when you make a purchase, every business you patronize until they publically answer the American Question.
16. To email every single candidate on every ballot and instruct them (no need to ask an employee) to sign or SHUT UP—your only excuse is a criminal one!
17. To add a link to your website and send a .PDF copy to all business and personal contacts.
18. To put a yard sign at your home or business for all to see that DEMOCRACY IS ALIVE IN AMERICA.
19. To remember that it only takes one(1) person on every street in America to make the phrase “Politics as Usual” to fade, forever into history!
20. To view this SYSTEM as a POLITICAL VIRUS for which there is NO ANTI-VIRUS. The only way to stop it, is to kill its host and this is the *real Mission: Impossible*.
21. To realize that no power on Earth can stop a thought once it is implanted into the human's central processing unit. No matter what is said, what is written, or what force comes against TRUE DEMOCRACY, only WE THE PEOPLE CAN STOP ITS SUCCESSION.

22. To join together with every American Citizen that is willing to **Pledge allegiance to the flag of the United States of America and to the Republic for which it stands, One Nation, Under GOD, Indivisible, with Liberty and Justice for ALL.**
23. To believe with every breath that you take that WE THE PEOPLE, with our God-given, political operating system, will uproot and destroy all of the enemies of our Freedom.
24. To never forget that The United States of America is the Nation that bears the Fruit of the Kingdom of God, and that no evil force from within or without will prevail against us, as long as WE THE PEOPLE hold to these principles.

## **Organization By-Laws**

1. Membership is limited to only verified adult, 18 years or older, citizens of the United States that maintain a physical legal address on the street and/or the street section that the organization is formed.
2. Each member may have only one identity within the system.
3. Each member must provide two(2) forms of proof of residency and citizenship
4. All members must pass a telephone CVSA test as to the truth of their residency and citizenship.
5. Each member must remain in good standing by participating at least once a calendar year in the CONSORTIUM CONTRACT ELECTRONIC VOTING SYSTEM.
6. No citizen or member may participate if he or she is convicted of a felony and/or does not live on the registered street block for at least three(3) months prior to any vote.
7. Any citizen may join any consortium group as long as they meet all membership requirements.

8. A street that has a long physical length and/or cuts across more than one subdivision and/or county line or municipal legal boundary may be divided into sections designated as an individual entity group.
9. Apartment buildings and/or complexes may be organized as a separate Consortium Organization but must have the same street and subdivision designation.
10. All National, State, County and individual street organization managers or legal representatives must submit to CVSA testing for verification of any information on any of its members physical and legal status—along with that of any matter involving the operation and/or the outcome of a “Voided Vote” or a candidate’s “Non-Trustworthy Status.”
11. Each Contract Consortium Electronic Vote must be verified by CVSA to be considered for its authenticity and that it has not been sold, conveyed, and or coerced by an outside party. Any members vote failing the individual CVSA vote analysis will be voided.
12. Any Individual’s Vote that falls within the 5% margin of error will be voided and classified as collateral damage, a casualty of truth, the whole truth, and nothing but the truth that WE THE PEOPLE have the right to expect and demand.

The undersigned Parties hereby agree to the following:

1. Are you or have you, at any point in your adult life, ever been a citizen of another country and/or territory other than that of the United States of America?

SECTION B:

1. Party Number One(1) agrees to accept and acknowledge each individual member of the partnership, Block 14-22, Robertson Street, Metairie Terrace Subdivision of the Parish of Jefferson in the State of Louisiana Contract Consortium Organization, LLC, as an individual entity within the same rights as the partnership and agrees to afford each member the legal right to file suit in and for any matter that is considered a BREACH OF CONTRACT with regards to this agreement.
2. Party Number One(1) agrees to hold harmless Party Number Two(2) and each individual member of Party Number Two(2) for any reason that and/or if Party Number Two(2) is not able to comply, elect, fulfill, and/or complete Party Number Two’s(2) contractual obligation with reference to Party Number One(1) being elected to the said Public office.
3. Party Number One(1) agrees to cast His or Her Official Vote on any and all issues that Party Number Two(2) designates as an Issue of Importance in accordance to Party Number Two’s organizational procedures in which Party Number Two(2) has provided its members the right and access to input their expressed wills by a formal vote within Party Number Two’s(2) system of democratic voting through Party Number Two’s(2) “Contract Consortium Electronic Voting System.”
4. Party Number One(1) agrees to bring to the appropriate legal body, the full will and/or request of legislation or referendum that Party Number Two(2) has voted on and approved, by the majority of votes cast within Party Number Two’s(2) System of Democratic Voting with reference to Section B-2 of this contract.
5. Party Number One(1) agrees, that at all times, to utilize a live internet camera, and/or audio/video recording device during any meeting, anywhere, with anyone that He or She meets with, with regard to government business and that the recorded meetings will be made available on the internet within 12

hours of said meeting with exception to a live internet broadcast to which He or She agrees to archive all broadcasts for permanent record in real time and on an internet website.

6. Party Number One(1) agrees to maintain an official active website within a twenty-four hour-live camera that shows the operation of His or Her Office and that the website will post all names, addresses and background information of all permanent and temporary employees and any volunteer staff along with, but not limited to, their personal and business/financial disclosure documents, including personal background checks, and the same for all officers of any company and/or organization that supplies services and/or advice or professional services to Party Number One(1) and/or his staff.
7. Party Number One(1) agrees to record and archive all landline and cellular telephone activity, including conversations and text messages, facsimiles including any Internet chat conversations and/or any over-the-air-waves communications by Ham and/or Citizen Band Radio concerning government business and/or any information relayed, conveyed, or transferred to Party Number One(1) by any third party communication from any source in regards to his official public position.
8. Party #1 agrees for the basis of this contract that Party #2 will not be bound by the prescriptive date for filing suite for BREACH OF CONTRACT in any legal jurisdiction, either in the United States of America and/or any of its territories, including but not limited to, any foreign country and/or territory.
9. Party Number One(1) agrees to relinquish the legal title and/or legal right for immediate seizure of any and all physical property and/or assets owned by Him or Herself including but not limited to property and/or assets held in Party Number One's(1) control and/or in a Trust, including but not limited to, property or assets held by others for Party Number(1) along with any assets that Party Number One(1) will acquire either legally or illegally, including salaries, wages, and/or gifts given to Party Number One(1) or acquired by Party Number One(1) for the duration agreed to in Section Six(6) of this contract agreement.
10. Party Number One(1) agrees for the basis of this EMPLOYEE CONTRACT AGREEMENT, that this contract and all of its parts, will remain in force for as long as Party Number One(1) remains alive and breathing, whether he or she remains in his or her official capacity or not, and/or is impeached, imprisoned, and or committed to a mental hospital or facility and/or resides in and/or becomes a citizen of a foreign country and/or territory.
11. Party Number One(1) agrees to submit himself or herself to CVSA and/or polygraph examination every 90 days to answer questions as to His or Her operation of the Official Elected Office and His or Her duties in the

representation of said office and to the truth of any question that party Number Two(2) has vote.

12. Party Number Two(2) agrees that the phrase, BREACH OF CONTRACT, as stated in Section B-3 of this Agreement, is or will, occur at a time, place, and/or event where Party Number One(1) casts his or her official vote in a manner other than that of the outcome of the official tally of that of the Contract Consortium Electronic Voting used by Party Number two(2) as stated in Section B-2 of this document and/or is found to be in intentional violation of Section B-1 through Section B-12.
